### DECLARATION

1. That I have fully & completely read and understood the terms & conditions mentioned in the annexure of this form and any violation may result in restricting the access from using the pool.
2. That I am fully & completely aware that the swimming pool is unmanned and there is no lifeguard patrolling the pool.
3. That members or the Executive Committee of FCAOA or the maintenance staff will not be held responsible in the event of any mishaps/injury/death or any such event caused during usage of the swimming pool by me or my family members declared above. No damage or compensation will whatsoever will be demanded by anyone whomsoever from FCAOA for any mishaps during the use of swimming pool.
4. That neither me nor my family members whose names are listed above, suffer from any epilepsy, cardiac conditions, contagious skin disease or any medical conditions listed in the annexure.
5. That if me or my family members whose names are listed above, develop any kind of such disease or medical conditions in the future, we will refrain ourselves from using the swimming pool and will re-join only after appropriate medical treatment/clearance from suitable medical practitioner.
6. That me and my family members will abide by the rules & regulations formulated and also the signs displayed in the swimming pool area.
7. That me or my family members will not allow entry / give access to any unauthorized / unregistered person other than above listed or my declared guests through the access-controlled door installed in the swimming pool area.

## Terms & Conditions

- The Executive Committee or any employees of FCAoA shall not be responsible for any accidents/mishaps which may occur in the Swimming Pool. The swimming pool is UNMANNED (No Life Guards on duty) and users are advised to use the pool at their own risk.
- The swimming pool should be used by members (residents) only. Children under 14 years of age / Children below 5 feet height / specially abled persons are not allowed to use the swimming pool, unless they are accompanied by a parent or an adult resident. Parents/guardians are advised to use floaters for children.
- The Executive Committee reserves the right to restrict the period and hours during which guests may be permitted and limit the number users, if the facilities are likely to be overcrowded, in the opinion of the Executive Committee. The decision of Executive Committee is final in this regard and can not be argued upon.
- The Swimming Pool shall remain open daily during the hours specified by the Executive Committee from time to time. The Executive Committee reserves the right to prescribe opening and closing times and to direct the facility to be closed.
- The EC reserves the right to impose and enforce penalties (fines/ expulsion/ suspension, debarment etc.).
- No tailgating entry is allowed using another users' credentials to the pool area. Tailgating means entering the pool area when the door is opened using another person's credentials.
- The Executive Committee recommends that all users should have a medical check-up prior to use of the Swimming Pool.
- No person is permitted to:
  - Enter the pool while suffering from epilepsy, cardiac conditions, contagious disease, open cuts, wounds, bandages, injuries, cold, cough, fever, skin disease, venereal diseases and upset stomach.
  - While in the pool or pool side area do any act, which is likely to endanger, obstruct, inconvenience or annoy any other person/ladies.
  - Throw or dispose of any litter, paper or rubbish into the pool.
  - Remove or interfere with any lifesaving apparatus or equipment.
  - Tamper, misuse any attachments or accessories fixed to the pool.
  - Enter the pool while drunk or in inebriated condition.
  - Engage in intimate or obscene gesture with fellow partner/any other person in the pool.
  - Use of abusive or profane language.
- Users should not engage in roughhousing (running, pushing, yelling, running, acrobatics or any other undesirable act) in or around the pool. Parents are requested not to indulge into above acts.
- Loitering or making reels in the pool deck is not permitted. No other activities except swimming is allowed in the pool or pool area.
- Pets are strictly not allowed in the pool area.
- Users are not allowed to enter into the pool without proper swimming costume and should wear well fitting Swimwear made of Lycra, Nylon etc. (Reason: These materials don't release minute fiber in the water which can block the filtration system. The fit is to ensure there is no loose fabric creating a hazard for you or other swimmers).
- Users having long hair should put on a swimming cap. Toddlers must be made to wear swim-proof diapers.
- It is mandatory for any person to take shower before entering the swimming pool and do not use creams or lotions before entering the pool.
- Users are requested not to carry any valuables to the swimming pool area. The management will not be responsible for any theft or loss.
- Food & beverages are not allowed in the swimming pool. Pool area should not be littered with food wrappers, cigarettes or any other trash. Glass bottles/any other glassware are not allowed in the pool or pool deck.
- Diving is not allowed in the pool. Spitting, spouting water from nose and mouth inside the pool are strictly prohibited.
- Photography and video recording will be allowed only with due permission and should be carried out ensuring that there is no violation of the privacy of others.
- Users are to follow the location specific signages for specific rules.
- These rules are subject to revision as and when necessary, by the Executive Committee.
